## **RESOLUTION 2023 - 063**

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF SOUTHWEST RANCHES, FLORIDA, SUPPORTING HONORARILY DESIGNATING THE PORTION OF S.R. 823/SOUTH FLAMINGO ROAD BETWEEN SOUTHWEST 52ND STREET AND SOUTHWEST 55TH STREET IN BROWARD COUNTY AS ARCHBISHOP EDWARD A. MCCARTHY HIGH SCHOOL WAY; AND PROVIDING FOR AN EFFECTIVE DATE.

**WHEREAS,** Archbishop Edward A. McCarthy High School is celebrating its 25<sup>th</sup> anniversary this year; and

**WHEREAS,** the State Legislature and the Governor approved the road honor designation for Archbishop McCarthy High School as follows: "That portion of S.R. 823/South Flamingo Road between Southwest 52nd Street and Southwest 55th Street in Broward County is designated as "Archbishop Edward A. McCarthy High School Way"; and

**WHEREAS,** the segment of S.R. 823/South Flamingo Road between Southwest 52nd Street and Southwest 55th Street in the City of Cooper City is under the jurisdiction of Florida Department of Transportation; and

**WHEREAS,** pursuant to Section 334.071, Florida Statutes, the designation of a state transportation facility (including a road segment) for honorary or memorial purposes requires a special act of the Florida Legislature, and markers/signage reflecting such a designation may only be placed along such road if the local government body passes a resolution in support of the designation; and

**WHEREAS,** the Town supports the Florida Department of Transportation to install signage reflecting this designation.

## NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF SOUTHWEST RANCHES, FLORIDA:

**Section 1.** The recitals above are true and correct and are incorporated herein by reference.

**Section 2.** The Town Council hereby supports honorarily designating that portion of S.R. 823/South Flamingo Road between Southwest 52nd Street and Southwest 55th Street in Broward County to Archbishop Edward A. McCarthy High School Way.

**Section 3.** This Resolution shall become effective immediately upon adoption.
